SB 5126: Concerning the Washington climate commitment act.

- The Climate Commitment Act puts a price on carbon pollution, caps emissions, reduces pollution over time, and includes several key provisions to address longstanding sources of pollution in overburdened communities in a way that includes direct community engagement and guidance.
- The climate crisis requires bold and decisive action and this bill takes a significant step forward as part of a thorough and multifaceted approach to meeting our climate goals.
- This bill was strengthened in the House Environment Committee, and we look forward to continuing the work with legislators to ensure its final passage.

SB 5192: Supporting access to electric vehicle supply equipment.

- Creates a consumer protection framework that will help ensure current and future electric vehicle infrastructure is accessible, reliable, and works for everyone.
- Establishes standards, so you know how much you're paying for fuel, how you're paying for fuel, that you're receiving the fuel that you pay for, and that the infrastructure is going to work for you when you need it to.

House Concurrence Action





HB 1091: Reducing greenhouse gas emissions by reducing the carbon intensity of transportation fuel (Clean Fuel Standard).

- Supports the deployment of clean transportation fuel technologies through a carefully designed program that reduces the carbon intensity of fuel used in the state, while cutting down pollutants that harm public health.
- It is critical that this priority policy passes in a strong form that provides longterm certainty for clean fuels investors. The current version of the bill requires amendments to re-strengthen the policy.
- One of three environmental community priorities for 2021.



HB 1168: Concerning long-term forest health and the reduction of wildfire dangers.

- Establishes dedicated fund account used for wildfire response, forest restoration, and community resilience in the face of fire and smoke.
- Establishes forest health workforce development initiative; directs use of environmental justice/equity tools as a factor in funding recommendations.



SB 5141: Implementing the recommendations of the environmental justice task force.

- Developed with input from communities statewide, this bill creates a definition of environmental justice, clear goals for addressing health disparities in overburdened communities, and improve state programs to better serve the public.
- Part of the environmental community's Partnership Agenda.
